

**FACTS****WHAT DOES SCORE MY CASH DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security number and transaction history</li> <li>• account balances and payment history</li> <li>• credit history and credit scores</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons SMC Ventures chooses to share; and whether you can limit this sharing.

### Who is providing this notice?

This notice is provided by SMC Ventures I, LLC, and is applicable to your Score My Cash account.

## What We Do

### How does SMC Ventures protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files.

### How does SMC Ventures collect my personal information?

We collect your personal information, for example, when you

- open an account
- give us your contact information or give us access to your bank transactions information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

## Definitions

### Everyday business purposes

The actions necessary for financial companies to run their business and manage accounts, for example:

- processing transactions
- initiating accounts

### Affiliates

Companies related by common ownership or control.

### Nonaffiliates

Companies not related by common ownership or control.

### Joint Marketing

A formal agreement, like a contract, between nonaffiliated financial companies that jointly market financial products to consumers.

## Other Important Information

### For Vermont Customers:

- We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.

### For California Customers:

In accordance with California law, we will not share information we collect about California residents with nonaffiliates, unless the law allows. For example, we may share information with your consent, to service your account. We will limit sharing among our companies to the extent required by California law.
