### WHAT DOES SCORE MY CASH DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us.  This information can include:  Social Security number and transaction history account balances and payment history credit history and credit scores	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons SMC Ventures chooses to share; and whether you can limit this sharing.

Definitions				
Everyday business purposes	The actions necessary for financial companies to run their business and manage accounts, for example:			
Affiliates	Companies related by common ownership or control.			
Nonaffiliates	Companies not related by common ownership or control.			
Joint Marketing	A formal agreement, like a contract, between nonaffiliated financial companies that jointly market financial products to consumers.

### For Vermont Customers:

• We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
